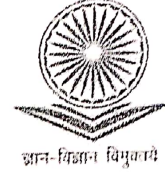

Subject:- Regarding mandatory accreditation of the colleges recognized under Section 12B of the University Grants Commission Act, 1956.

Sir / Madam,

In accordance with the decision taken in the 559th meeting of the University Grants Commission (UGC) held on 13th June, 2022, I am to inform you that the NAAC Accreditation is mandatory for Higher Educational Institutions to become eligible for recognition under section 12B of the UGC Act, 1956 and the HEIs which have already been given 12B status may be given maximum of five years to obtain NAAC accreditation to retain their recognition u/s 12B of the UGC Act, 1956. Accordingly, the colleges previously recognized under Section 12B will be required to obtain accreditation latest by June 2027. In view of the above, it is requested that all the affiliated / constituent colleges recognized under Section 12B of the UGC Act be informed to comply with the accreditation requirement.
