## **Responsibilities of Abhiyan Theatre Group:**

Theatre activities, including acting, direction, scriptwriting, and stagecraft. Personality development, including communication skills, confidence building, teamwork, and leadership skills.

- Abhiyan will provide expert trainers, including professionals from reputed institutions like the National School of Drama, Film and Television Institute of India, and Bharatendu Natya Academy.
- 3. Abhiyan will conduct all training and workshops at its own training center.

### Responsibilities of Deen Dayal Upadhyaya Gorakhpur University:

1. The University will provide necessary infrastructure, including auditoriums, halls, and classrooms, for training and performance activities.

The University will bear all necessary expenses, such as electricity bills and 2. auditorium charges, if any programs are organized in collaboration with Abhiyan and the University.

The University will promote theatre activities and personality development programs

among its students through awareness campaigns, notices, and circulars.

4. The University will facilitate the active participation of its students and faculty in theatre related workshops and events organized by Abhiyan.

**Duration:** 

This MoU shall remain in effect for a period of three (3) years from the date of signing and may be renewed upon mutual agreement.

Termination:

Either party may terminate this MoU by providing a written notice of three months, stating the reason for termination.

**Dispute Resolution:** 

Any disputes arising out of or in connection with this MoU shall be resolved amicably through mutual discussions. If unresolved, the matter will be referred to an arbitrator mutually agreed upon by both parties.

**General Provisions:** 

1. Both parties will maintain mutual respect and professionalism in all collaborative activities.

2. This MoU does not create a legal partnership or joint venture between the parties.

3. All intellectual property created as part of this collaboration shall be jointly owned by

both parties unless otherwise agreed in writing.
