Memorandum of Understanding

This Memorandum of Understanding (MoU) is entered into between Centre of BioMedical Research (CBMR) an autonomous body under the Government of Uttar Pradesh, SGPGIMS Campus, Raebareli Road, Lucknow – 226014 hereinafter called CBMR.

AND

Deen Dayal Upadhyaya Gorakhpur University situated at Civil Lines, Gorakhpur – 273009 hereinafter called DDUGU, Gorakhpur.

Sharing a common desire to extend and strengthen the functional relationship between CBMR and DDUGU, Gorakhpur we the undersigned, mutually agree to share existing facilities and available expertise at our respective institutions viz. CBMR and DDUGU, Gorakhpur by signing a MoU on **28th Feb. 2025** which reads as follows:


1. The major objective is to establish a close linkage and functional coordination between CBMR and DDUGU, Gorakhpur for mutual cooperation towards the advancement of knowledge of the employees, faculty and students of both the institutions.
2. CBMR and DDUGU, Gorakhpur will both provide intellectual and infrastructure support for carrying out collaborative academic research in the areas of mutual interest. A prior approval of each research activity under such collaboration is required from the competent authorities of both the organizations. Mutually approved

research projects will be executed without any financial liabilities on each other for recurring expenses after assessing the priority. The outcomes of the studies in terms of research papers, patents, products, etc will be jointly shared by the individuals from both the organizations.

3. CBMR and DDUGU, Gorakhpur will encourage and provide facilities to faculty members of DDUGU, Gorakhpur and CBMR to explore and prepare joint proposals on thrust areas for funding. The technical activities and grant sharing between CBMR and DDUGU, Gorakhpur shall be mutually agreed while submitting such proposals to funding agencies. The outcomes of the joint research in terms of research papers, patents products, etc will be jointly shared by individuals of both the organizations as per their contributions.
4. The research orientation programme for the early and mid career faculty members of DDUGU, Gorakhpur may be conducted at CBMR and vice versa. The duration, frequency, adequacy and other modalities of such orientation programme can be decided on mutual consent.
5. CBMR faculty members can be Co-Guide for Ph.D Programme of DDUGU subject to adherence to the academic policy of the University.
6. For ethically approved studies, DDUGU, Gorakhpur will provide the demographic data and biological materials including the tissues of human volunteers.
7. CBMR and DDUGU, Gorakhpur may jointly organize Seminars/ workshops/ Conferences and short-term training programme on the topics of mutual interest.
8. DDUGU, Gorakhpur may offer honorary positions of visiting/ adjunct Professors to the faculty members of CBMR as per the norms of DDUGU, Gorakhpur.
9. These arrangements shall be valid for a period of five years commencing from the date of signing of this MoU and its continuance will be subject to review after the expiry of the agreed period of five Years.
10. Any disputes arising will be settled by mutual negotiation between the two parties.


