# **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (MoU) is signed at on this day of,

#### **Between**

### **Construction Industry Development Council (CIDC)**

(Established by the Planning Commission, Govt of India)

having its registered office at801,Hemkunt Chambers, 89, Nehru Place, New Delhi-110019hereinafter called the "First Party" (which expression shall, unless repugnant to the context, includes its successors and assignees of the First Party).

## **Deen Dayal Upadhyay Gorakhpur University**

(A UP State University established under Uttar Pradesh State University Act, 1973)
Having its office at Civil Lines, Gorakhpur, 273009hereinafter called the "Second Party" (which expression shall, unless repugnant to the context, includes its successors and assignees of the Second Party).

WHEREAS, the First Party has launched Internship, Faculty Development Programs and Short- & Long-Term Training programs for the students and faculties of all disciplines in Engineering & Management. CIDC in association with AICTE, has agreed to promote internship with industrial houses and

government/ semi- government organizations as also to undertake other programs to help Engineering Colleges to meet their internship obligations in line with the Internship Policy of AICTE.

AND WHEREAS, the Second Party is desirous to associate with First Party for conducting Internship, Faculty Development Programs, capacity building and other training programs for students and the faculties and agrees to send students and faculties to the First Party approved centres and locations for the said programs at mutually agreed terms and conditions.

NOW, THE FIRST AND SECOND PARTIES herein and hereby agree to collaborate for the purpose of initiating, developing and implementing programmes of Internship, Faculty Development and other training programs, capacity building offered by First Party.

#### 1. Construction of the MoU

1.1 The MoU shall be governed by and construed in accordance with the laws of the land.

#### 2. Provisions of the MoU

- 2.1 The First Party and the Second Party shall cooperate with each other for fulfillment of their mandates and requirements.
- 2.2 The Second Party shall encourage and facilitate students and faculties of Deen Dayal Upadhyay Gorakhpur University and its affiliated collegesto get the Internship, Faculty Development, Skill Development, training and capacity building from the First Party.
- 2.3 The First Party shall facilitate to the Second Party to fulfill the context of mandatory provisions of Internship and capacity building, FDP.
- 2.4 Based on the need, First Party may support the Deen Dayal Upadhyay Gorakhpur University and its affiliated collegesto design the systems in fulfillment of above and have implemented through the training centers/ institutions/ universities and the industry.
- 2.5 The First Party is responsible for providing the syllabi, curricula and the resources for the programs to be offered to the Second Party.
- 2.6 The First Party shall conduct examinations and issue certificates to the successful candidates trained under the programs.
- 2.7 The First Party shall have complete authority for all acts and omissions of its staff and/or any persons, associations, institutions and resources.
- 2.8 The Second Party is responsible for creating awareness among its students and faculties regarding the programs to be offered by the First Party.

- 2.9 The Second Party shall send the details of interested students and faculties at the time of start of the academic session and semester to the First Party for necessary planning and registration activities. The Second Party shall coordinate with the First Party to select the students/ faculties for the programs and to send them to the training centers/ approved industry locations.
- 2.10 The internship for the students is according to the Second Party curriculum. Therefore, the schedule of internship along with its duration and time shall be proposed by the Second Party to the First Party.
- 2.11 The location for carrying out the student internship will be worked out through mutual agreement and the internship will be conducted by the students during their academic calendar as per the Second Party's regulations governing their program.
- 2.12 The eligible students who have undergone offline internship with the First Party will be given placement assistance by the First Party.
- 2.13 The fee for the training, internship, faculty development program or any other program will be decided jointly on case-to-case basis. The First Party will give the opportunities to the students of the Second Party under the internship/ training/ skill development under CSR schemes and other government sponsored schemes.
- 2.14 The Second Party shall send the details of eligible and interested faculties for the Faculty Development Program and other programs at the time of start of the academic session and semester to the First Party for necessary planning and registration activities.
- 2.15 The Second Party shall ensure the provision of minimum number of interns and the faculties to run the programs.
- 2.16 Second Party will not be liable directly or indirectly for any loss or damage caused to any material or life by the act of First Party or its representatives during conducting the activities during the project period or then after.

#### 3. Amendment

3.1In case any amendments are required in any part of the MoU, the Parties on mutual agreement in writing shall incorporate such amendments by way of amendments to this MoU which shall be binding and be followed by the parties.

### 4. Settlement of disputes

4.1The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this MoU or the interpretation thereof.

This Tho U will become effective on the date of signing and will have a duration of five (5) years. However, it can be extended by mutual agreement, Anycessation of the MoU by either Party shall be notified in writing to the other Party at least six months in advance.
