Whereas first party consisting of sons and relation of Late Pandit Harihar Pd. Dube Advocate, Secretary of Gorakhpur University foundation society and one of the founders of this University wants to contribute for scholarships in name of Late Pt. Harihar Prasad Dube for students pursuing Post graduate study in the Departments of Physics, Mathematics & Zoology at Deen Dayal Upadhyay Gorakhpur University, Gorakhpur to which the second Party has agreed.

The first party has offered to deposits a handsome amount of Rs. 9,20,000/- vide cheque no. ~~889753~~ dated ~~20-5-2019~~ for amount Rs. 9,20,000/- drawn in favour of Deen Dayal Upadhyay Gorakhpur University, Gorakhpur to which Rs. 4,00,000/- + its interest Rs. 1,88,624/- has been added to make the hole scheme financially viable.

Rs. 4,00,000/- along with its interest Rs. 1,88,624/- is being transferred from Pandit Harihar Pd. Dube Memorial Lecture fund with the consent and agreement of both parties. Thus the total fund available for scholarship scheme becomes Rs. 15,08,624/-.

The cheque as referred to above for amount Rs. 9,20,000/- has been handed over to the Vice Chancellor, Deen Dayal Upadhyay Gorakhpur University, Gorakhpur.

In this connection, the following terms and conditions have been agreed upon between the first party and the second party-

1. Out of the interest income of the donation of Rs. 15,08,624/- made by the First Party, the second party will annually award the merit Scholarships to the students of Departments of Physics, Mathematics and Zoology under the nomenclature of Pt. Harihar Prasad Dube Memorial Scholarship.
2. The first scholarship will be awarded to the student who has obtained

highest marks in subjects namely Physics, Mathematics & Zoology in order of merit in B.Sc. Examination and is perusing Post Graduate course in respective departments in the current session of Deen Dayal Upadhyay Gorakhpur University, Gorakhpur.

3. The Second Scholarship will be awarded to a student who has obtained highest marks in his/her respective subjects in order of merit in M.Sc. Part I Examination and is pursuing M.Sc. (Final) in subjects of Physics, Mathematics and Zoology in Deen Dayal Upadhyay Gorakhpur University, Gorakhpur.
4. Both the Scholarships will be of equivalent amount and will be awarded for a period of 20 months to the M.Sc. Previous students and for a period of 10 months for the M.Sc. (Final) student.
5. For each scholarship the Second party will prepare a panel of three students in order of merit, and submit it to No. 1 of the first party i.e. Vinay Dube who will execute a final choice of the students who will be awarded the scholarships.
6. After the demise of Vinay Dube, Deepak Dube, grand son of Pt. Harihar Prasad Dube will execute a final choice of the students eligible for the scholarships.
7. After the demise of Deepak Dube the trust will nominate a person in his place for final choice of recipients of the said scholarships.
