Memorandum of Understanding (MoU)

Between

The Directorate of Horticulture and Food Processing, Government of Uttar Pradesh And

Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur

This Memorandum of Understanding (MoU) is entered into on this 21.11.2024 at Lucknow, between: The Directorate of Horticulture and Food Processing, Government of Uttar Pradesh (hereinafter referred to as the "Directorate"), having its office at Udyan Bhawan, 2 Sapru Marg, Lucknow (UP), and

Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur (hereinafter referred to as the "University"), located at Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur Uttar Pradesh.

This MoU is executed to formalize the empanelment of the Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur as a Third-Party Inspection Agency (TPIA) under the Uttar Pradesh Food Processing Policy, 2023. The University will be responsible for conducting inspections of food processing enterprises to assess compliance with policy guidelines. Based on the inspection reports, the Directorate will proceed with the release of subsidies under the scheme.

Uttar Pradesh Food Processing Industry Policy 2023 (Scheme Guideline, Terms & Condition of

Uttar Pradesh Food Processing Industry Policy 2023 aims to increase the processing of agricultural and allied sector produce in the state and promote the export of processed food items.

Capital Subsidy: i.

- Amounting to 35% of incurred expenditure on plant, machinery and technical civil work for FPIs subject to maximum of Rs. 5 Crores.
- In case of expansion and modernization / up-gradation, capital subsidy will be 35% subject to maximum of Rs. 1 Crore.
- Subsidy on solar power projects for electricity supply to processing units: 50% subsidy on solar power utilities in rural areas and 90% subsidy for women entrepreneurs in the same ii.
- 25% Freight Subsidy on exports excluding Nepal, Bangladesh and Bhutan.
- Scheme for value addition and cold chain infrastructure: Subsidy of 35% for infrastructure pertaining to Cold Chain and Value Addition and a subsidy iii. of 50% up to Rs. 10 Crores for frozen storage/deep freezer, value addition and processing iv.
- Subsidy of 50% up to Rs. 50Lakh for establishment of Agro processing cluster storage v.
- Permission topurchase land (agricultural) for more than 12.5 acres for FPIs.
- Exemption from charges of 2% of the value at circle rate as fees for non-agricultural use vi. vii.
- Fees for Exchange of government owned landcoming under the scope of the project site viii. will not be applicable for FPIs.
- Conversion of Land Use: 50% fees will be waived off on CLU ix.
- External Development Charges: Rebate of 75% on external development charges for FPI to be setup in UP on a land where no developmental work has been done by Authorities.
- 100% exemption from stamp duty for the land purchased for the establishment of food X. xi.
- Exemption from Mandi Fees and cess for agricultural produce procured from other states xii.
- Exemption from Mandi fees and cess for agricultural produce directly sold to processing xiii.
- Sponsoring studies for certifying / declaring an area disease free i.e.- potato Agra & xiv. Kannauj; Durum wheat-Bundelkhand.

Roles and Responsibilities:

Department of Horticulture and Food Processing:

- To provide the University with a list of food processing enterprises requiring inspection under the policy and LoC on Same day as approved by SLEC.
- To furnish necessary guidelines, evaluation criteria, and formats for reporting.

To ensure timely payment of inspection expenses, fees, and honorarium as per the policy guidelines based on quality of inspection.

Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur:

- To conduct detailed inspections of food processing enterprises as per the standards and guidelines shared by the Department.
- To prepare and submit comprehensive inspection reports within the stipulated timeframe.
- To ensure impartiality, transparency, and professionalism in conducting inspections.
- To maintain confidentiality of all information accessed during inspections.
- Creating a mechanism for efficient reporting.
- Conducting inspections for approved and fund-supported units.
- Ensuring adherence to quality standards.
- Submitting detailed reports on inspections on timeline.
- Facilitating the release of capital subsidies based on inspection reports.
- Required manpower Food Technologist / Food processing Expert, Mechanical / Civil Expert
- Number of visits is expected to make minimum 2 visits of the project site.

As per the provisions of the Uttar Pradesh Food Processing Policy, 2023, Third Party Inspection Agency (TPIA) will be paid as per the norms of policy. This amount will be released in two instalments. The first- Instalment will be released after submitting report of first instalment and final instalment will be paid after visit for recommending final payment to the industry. In case of export cases the amount will be for examination of the documents of the exporters. The payments will be made for review of the document basis exclusively.
