MEMORANDUM OF UNDERSTANDING (MoU)

This memorandum of understanding is made on 28th Day of the month of October in the Year 2020 between Mahayogi Gortakhnath Krishi Vigyan Kendra Chaukmafi, (Jangal Kaudiya), Peppeganj [promoted by Indian Council of Agriculture Research (Ministry of Agriculture and Farmers Welfare) Government of India] which is represented by its Head, herein named as Party one and Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur represented by its Finance Officer, herein named as Party two.

The above parties hereto agree as follows:

1. Party one declares that Mahayogi Gortakhnath Krishi Vigyan Kendra is a research institution and intent to cooperate and focus its efforts on cooperation within the area of Entrepreneurship Development through promotion of FPOs, conducting outcome based trainings, R&D and related services such as education along with advanced and applied research.
2. The Second Party is engaged in research, skill development, and R&D activities in several academic disciplines including the fields of entrepreneurship development, GIS, Agriculture and related fields.
3. Party one and Part two agrees that, both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
4. The industrial training, promotion of FPOs and exposure provided to students, faculty and other stakeholders through this association will build confidence and prepare the incumbents to have a smooth transition from academic to working career, for which institutions can charge a nominal fee as per their existing provisions or as per the mutual agreement in writing.






