#### MEMORANDUM OF UNDERSTANDING

This Memorandum Of Understanding ("MOU") is made on this day, 3<sup>rd</sup> day of October, 2023 by and between

**Psyuni Institute of Psychology and Allied Sciences, Lucknow** having its head Office at "", (hereinafter referred to as "PIPAS" which expression shall mean & include unless repugnant to the context or meaning thereof, its successors & permitted assigns) of the One part

AND

**'Deen Dayal Upadhyaya Gorakhpur University, Gorakhpur'** established by an Act of U.P. State Legislature in the year 1973, (hereinafter referred to as "DDUGU, Gorakhpur", which expression shall mean & include unless repugnant to the context or meaning thereof, its successors & permitted assigns) of the other part.

PIPAS & DDUGU, Gorakhpur are hereafter referred to individually as "Party" and collectively as "Parties".

#### PREAMBLE

**Whereas**, PIPAS, Lucknow is engaged in providing training, value, culture & education in Psychology to students in India & abroad. It is an Institute dedicated to building the super specialized and skilled work force to provide a range of psychological services. Also, to ensure quality of psychological services to the community at large.

**Whereas**, DDUGU, Gorakhpur is a leading educational institute approved by UGC, India, offering courses in Graduation/Post Graduation/ PG Diploma/ PhD etc.

**Whereas,** PIPAS as a part of its Student development and training activities desires to collaborate with DDUGU, Gorakhpur under Department of Student Welfare for promoting special education in accordance with psychological attributes to enhance personality & attitude among students undergoing education in the university for all branches and all courses, so as to help them develop a healthy mindset & balanced lifestyle which is much needed by the modern youth of today.

**Whereas,** DDUGU, Gorakhpur has shown its readiness to collaborate with PIPAS & to provide all required infrastructure & facilities for running & conducting the various programs such as workshops, guest lectures, seminars, events etc. from time to time throughout the whole academic year.

**Therefore,** in consideration of the foregoing & mutual covenants and promises contained herein the Parties agree as follows-

It is agreed between the parties that PIPAS & DDUGU, Gorakhpur shall work together on **non-exclusive** basis for the programs organized in collaboration with PIPAS.

Role & responsibilities of each party will be as under:

1. Students of Department of Psychology, DDUGU, Gorakhpur will undergo their training/ internship and research work under the guidance of a psychiatrist/ clinical psychologist/ counselor to learn and help in case study, assessment, treatment of cases and data collection.
2. The student will be provided adequate supervision during their placements as per the days and time prescribed by the time table contact programme schedule. They shall follow the all the ethical codes of conduct related to the organization.
3. Students will be allotted and exposed to assessments and sessions in psychotherapy, psychiatry and OPD/IPD/ward rounds with psychiatrists, doctors as required for the completion of their programs and objectives.
4. Students pursuing diploma/master / PhD courses will assist the clinical psychologists/ psychiatrists/ counsellor/ therapy, if permitted.
5. For furthering the cause of enhanced community mental health PIPAS and DDUDGU may jointly organize mental health camps, workshop, symposia, training courses/ conferences on topics of mutual interest.
6. Faculty of PIPAS with clinical background and expertise will visit department of Psychology, DDUGU from time to time as subject experts and guide for training in testing, analysis, therapies on patients.
7. Each student for the duration of training/internship at the centre will be charges a subsidized fee as prescribed by the management of PIPAS.
8. At the end of the clinical training PIPAS, is to provide a certificate of training / experience of each student posted at the institution / hospital/ society/ centre for their training.
9. The validity of the document is for three academic years or as necessary.






