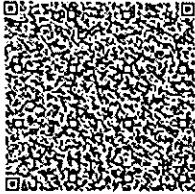

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered into this 19/09/2024.

BETWEEN

DeenDayalUpadhyaya Gorakhpur University, a premier state university, accredited A++ by NAAC ,established in 1957 by the Uttar Pradesh State Universities Act 1973, Government of Uttar Pradesh, having its registered office at Gorakhpur 273009, Uttar Pradesh (hereinafter called DDUGU which expression shall where the context so admits include its successors and permitted assigns) OF THE ONE PART,

AND

Vivekananda Rock Memorial and Vivekananda Kendra in short Vivekananda Kendra - a spiritually oriented service organisation registered under Societies Registration Act, 1860 (Reg. No. 34 of 1963) having registered office at 5 Singarachari Street Triplicane. Chennai 600005 and Administrative Office at Vivekanandapuram, Kanyakumari- 629702 is engaged in various social service activities like Education, Rural Development, Tribal Upliftment, Yoga, Renewable Energy Resources etc. VKK is engaged in the field of Yoga for more than 45 years conducting various Yoga based and personality development courses for all sections and age groups of the society.

(herein after called 'VRMVK' which expression shall include its successors in interest and permitted assigns)OF THE SECOND PART,

The 'DDUGU' and 'VRMVK' recognize the respective strengths of the two organizations and the fact that they are complimentary to each other and accordingly agree to cooperate in the development of spirituality and academics and their successful transfer to Spiritually Oriented Service and academics works. The

'DDUGU' and 'VRMVK' have decided to sign a Memorandum of Understanding (MOU) as per following objectives ,terms and conditions:

OBJECTIVES OF THE MOU

The Objectives of MoU are:

1. To conduct Personality development and Leadership Development workshops and **Value added courses s(as per syllabus of VRMVK)** for students.
2. To train Yoga Teachers by conducting Yoga Certificate Course and Sharpen teaching and learning skills of Yoga
3. To introduce traditional Yoga texts to the yoga Teachers
4. To conduct Residential and Non Residential Yoga courses all over DDUGU covered area.
5. The MoU is purely for the purpose of spreading the Yoga and personality development programs in all its dimensions.
6. To encourage and promote deeper studies in Yogic knowledge.
7. To yoga as an Art and Science to build values in life and there by build a value based society.
8. To conduct various Yoga oriented courses for students and staff.
9. To conduct various Yoga oriented courses for students and staff of various departments,colleges and institutions affiliated and managed by DDUGU, Gorakhpur.
10. To Conduct Yoga courses for general public under the banner of VRMVK and DDUGU.
11. To conduct Teachers orientation workshops for staff.
12. DDU Gorakhpur University and Vivekananda Kendra, Kanyakumari shall work together for green development of villages in Gorakhpur, Kushinagar and Deoria Districts with the concept of Yoga is the way of life.

Technical Areas of Collaboration

1. To expose the candidates to the various aspects of utilities of Yoga in present times
2. To impart professional skills to a Yoga teacher and students for their career.
3. To organize Yoga based Personality development courses and camps
4. To impart Yoga training to improve health of the participants.
5. Take yoga as a tool for a better living in tune with nature.
6. Participants can write various examinations conducted by Yoga Certificate Board (YCB) under Ministry of AYUSH, as per YCB syllabus.


Terms and Conditions

1. Vivekananda Kendra will provide the experts and course material. In order to meet all the expenses, a nominal registration/admission fee, course fee and examination fee will be received from the participants by Vivekananda Kendra after the approval of the university.
2. Sharing of infrastructure and Laboratory facilities free of cost to extend the collaborative activities, examinations between two parties.
3. Exchange of faculty and students between both the parties for the mutual benefits of either of the institutions.

4. The course fee may vary from place to place and time to time after mutual consent of both the parties.
5. The entire process of teaching and training will be monitored by VRMVK and DDUGU.
6. Both VRMVK and DDUGU agree to extend full support to maintain the highest standards of certification.
7. VRMVK shall arrange Hostel/Guest House accommodations for DDUGU faculty and students coming to VivekanandKendra , Kanyakumari for yoga and spiritual work. DDUGU shall also arrange Hostel/Guest House accommodations for VRMVK, adhikari, trained jeevanvrati.andsevavrati.
- 8.It is agreed that the progress of this MOU will be monitored by the Director, MahayogiGuru SriGorakshnathSodhpeth and Nagar Pramukh, VRMVK, Gorakhpur through periodic meeting as required with the permission of higher authorities.
9. This MoU can be amended, renewed and terminated by written agreement of VRMVK and DDUGU.
10. Both DDUGU and VRMVK maintain the Swami VivekanadVatika inside the campus of University.




