#### Background:

The Marian Foundation, herein referred to as "the Foundation," is a non-profit organization committed to promoting education, health and sports development. DDU University, Gorakhpur, herein referred to as "the University," is a renowned educational institution dedicated to academic excellence and holistic student development established in the city of Gorakhpur.

## Purpose:

This Memorandum of Understanding (MoU) is established to formalize the partnership between the Foundation and the University for the implementation of

- 1. The Marian Foundation Academic Scholarly
- 2. The Marian Foundation basketball fellowship programme aimed at supporting deserving students and fostering athletic talent.
- 3. And the Marian Alumni Mentor Programme.

#### **Terms of Agreement:**

#### 1. Academic Scholarships:

- The Foundation agrees to provide financial assistance in the form of academic scholarships to meritorious students enrolled in undergraduate at DDU University.
- The selection criteria, eligibility requirements, and the number of scholarships awarded annually shall be determined jointly by the Foundation and the University.
- The scholarship shall be for 3 girl child students decided on the basis of the top three girl students as an outcome of the Universities entrance examinations.
- An additional academic resource fee of Rs:10,000 shall also be provided by the foundation to the chosen students over and above the university tuition fee.

### 2. Basketball Fellowship Programme:

- The Foundation shall sponsor a basketball fellowship programme at DDU University to nurture promising basketball players.
- The fellowship shall include coaching, training facilities, equipment, summer and winter camps at the St. Paul's School Campus and other necessary support to enhance the skills and performance of the selected candidates.
- The University shall facilitate the integration of the fellowship programme within its existing sports infrastructure and academic schedule.
- The foundation shall sponsor the Universities women's basketball team for the year 2024 and hold mentoring and mental well-being classes for the motivation of the team.
- The foundation jointly with the university shall create awareness for the team through all channels of media.

#### • The foundation shall further provide:

- (1)2 annual health check-ups for the entire team
- (2) Provide playing kit for the team and coaches
- (3) Provide logistics support for the team to travel and represent itself across the various championships.

#### 3. Duration:

• This MoU shall remain in effect for a period of one year commencing from the date of signing of the 9<sup>th</sup> of March,2024, unless terminated by mutual agreement or for reasons stated herein.





### 4. Responsibilities:

- The Foundation shall bear the financial responsibilities associated with the scholarship and fellowship programme, including but not limited to tuition fees, stipends, travel expenses, and administrative costs.
- The University shall provide necessary administrative support, facilitate the selection process, and ensure the smooth implementation of the programme.

### 5. Monitoring and Evaluation:

- Both parties agree to conduct periodic reviews and evaluations of the scholarship and fellowship programmes to assess their effectiveness and identify areas for improvement.
- Any necessary adjustments or modifications to the programmes shall be made collaboratively based on the outcomes of the evaluations.
- The reviews shall be conducted under the able guidance of the Universities Vice-Chancellors office and the Chief Trustee of the Foundation.

#### 6. Confidentiality:

Both parties shall maintain the confidentiality of sensitive information shared during the course of collaboration under this MoU.

#### **Dispute Resolution:**

In the event of any dispute arising out of or in connection with this MoU, the parties shall seek an amicable resolution through mutual discussions. If the dispute remains unresolved, it shall be referred to arbitration in accordance with the prevailing laws of the state of Uttar Pradesh and within the city of Gorakhpur.
